You will find many different flyers and forms in your tournament package. Please feel free to photocopy them as needed. We hope to see you there!

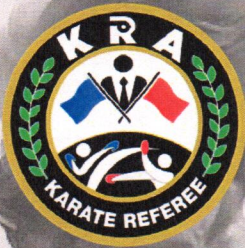

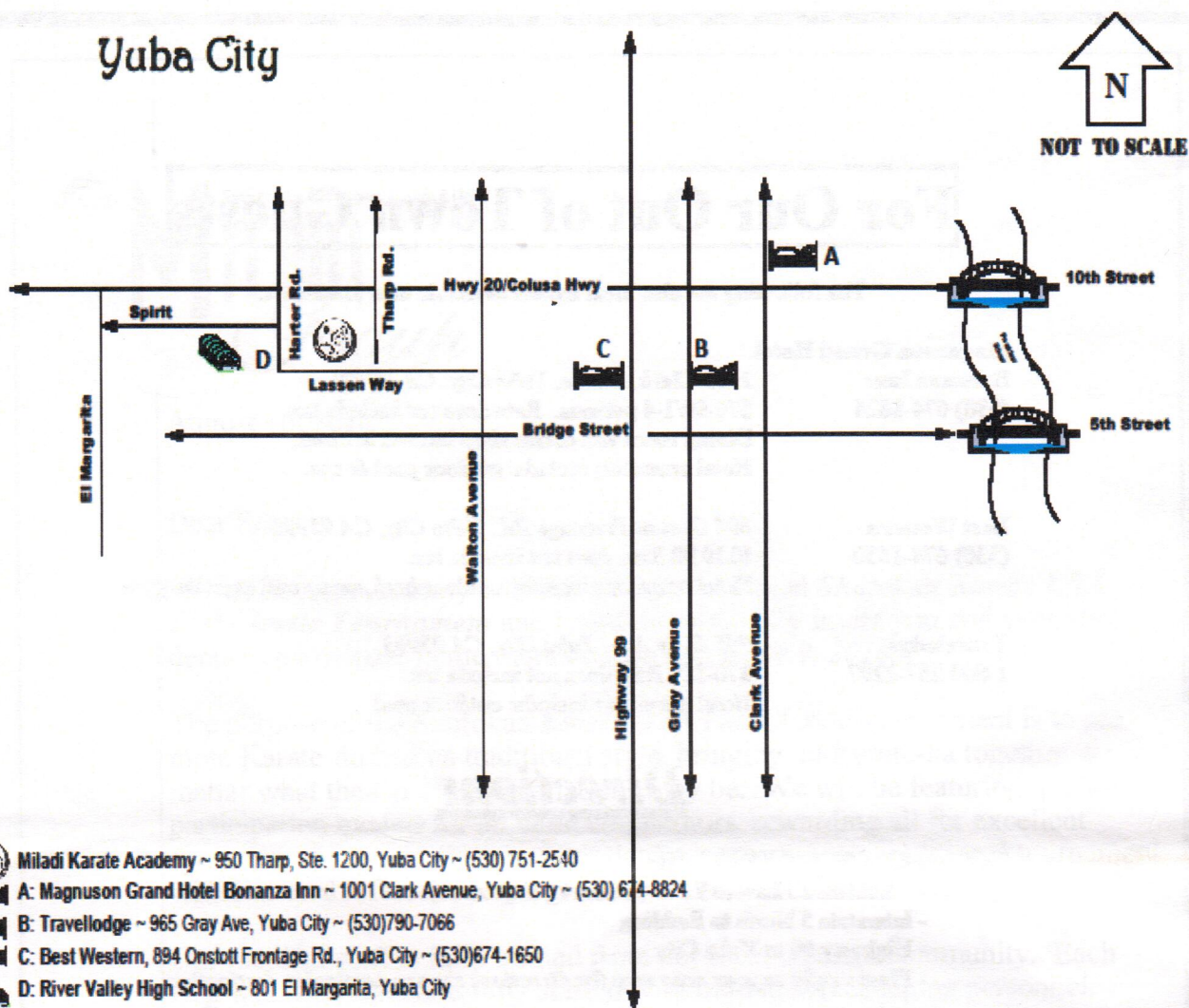
